EMD in the prescribed format drawn on or before the schedule date of receipt of Tender and cost of Tender schedule which should have been drawn in favour of the undersigned on or before the last date for receipt of Applications for issue of Tender schedule (Applicable only for Tenderers who have downloaded the schedule from Web) with proof of document on their eligibility as per the conditions of Press notice and the envelope shall be super scribed as 'EMD / Cost of schedule' and the other envelope shall be super scribed as "TENDER SCHEDULE".

On the scheduled date of opening, the tender schedule of all the Sthapathy, the cover super scribing 'EMD / Cost of schedule' shall be opened first and on fulfillment of cost of Tender schedule / payment of Earnest Money Deposit, eligibilities only the other envelope super scribing as TENDER SCHEDULE will be opened. The Sthapathy's envelope "Tender schedule" which does not satisfy the conditions of Press notice, will be returned unopened.

If the opening day of tender happens to be a Public Holiday, the same will be opened on the next working day.
