TENDER NOTICE FOR e-Tender

For & On behalf of Sri Dharbaranyeswaraswamy Devasthanam, Thirunallar, tenders are invited by the Executive Officer (Temples), Sri Dharbaranyeswaraswamy Devasthanam, Thirunallar, Karaikal, for the following work from the eligible contractors/firms. **Contractors other than those registered with PWD, Puducherry** should produce documentary evidence in support of their having satisfactorily completed three similar works each of **40%** of estimate cost put to tender or two works each of **60%** of estimate cost put to tender or one work of **80%** of estimate cost put to tender in the last **seven** years ending **previous day of last date of submission of tenders**. (Similar work means execution of "Civil Works") The value of executed works shall be brought to current costing level by enhancing the actual value of work done at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications for tenders. **The contractor after purchasing the valid ikey and Digital signature Certificate** can only be able to download the Press Notice, Notice Inviting Tender and other related documents and upload the bid document online by verifying the Tender Number assigned for each work from www.pudutenders.gov.in

1. The intending bidder must read the terms and conditions of FORM-6 carefully. They should only submit the bid if they consider themselves eligible and they are in possession of all the documents required.
2. Information and Instructions for bidders posted on website shall form part of bid document.
3. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.pudutenders.gov.in at free of cost.
4. The contractors shall submit EMD and e-tender processing fee on or before 5.45 PM on 19.02.2026 and in the form of Demand Draft / Bankers Cheque / Fixed Deposit receipt in favour of The Executive Officer (Temples), Sri Dharbaranyeswaraswamy Devasthanam, Thirunallar in **his office** and the same shall also be scanned and uploaded
5. The tender of the contractor who do not deposit the EMD and e-tender processing fee on or before 5.45 PM on 19.02.2026 in the office of The Executive Officer (Temples), Sri Dharbaranyeswaraswamy Devasthanam, Thirunallar will be summarily rejected.

List of Documents to be scanned and uploaded within the period of bid submission:
MANDATORY DOCUMENTS

- 1) The contractors shall submit EMD and cost of tender schedule on or before 5.45 PM on 19.02.2026 and in the form of Demand Draft / Bankers Cheque / Fixed Deposit receipt in favour of The Executive Officer (Temples), Sri Dharbaranyeswaraswamy Devasthanam payable at Thirunallar in his office. A copy of same shall also be uploaded with the tender. This office will not be responsible for any delay in the realization of EMD / e-tender processing fee. The contractors who had downloaded the Tender Schedule from the website shall submit the Tender Schedule online before the scheduled time for submission of tenders online. (No- tender schedule brought to the Office of the Executive Officer for placing in the Tender box is allowed).
- 2) All contractors should upload PWD/CPWD/MES/Railways/TWAD/ Any state PWD Registration Certificate / Enlistment Order of the appropriate class.
- 3) Certificate of Registration for GST, and Acknowledgement of up to date filed return of GST (not earlier than three months prior to last date of tender submission).
- 4) If the bidder has not obtained GST registration as applicable, then he shall scan and upload following undertaking along with the bid document "If work is awarded to me, I/we shall obtain GST registration certificate, as applicable, within one month from date of receipt of award letter or before release of any payment whichever is earlier, failing which I/we shall be responsible for delay in payments which will be due towards me/us on account of the work executed and/or for any action taken by PWD or GST department in this regard."
- 5) Contractors / Firms other than those registered with PWD, Puducherry shall upload the Form "C" (Page No.6) that the statement of details of completed works as per the eligibility criteria specified in the NIT. Necessary Attested copies of the Work Order, final completion certificate from the client for the said work(s) in Form "C" have to be attached. (Originals documents have to be submitted after Opening of the eligibility criteria Bid).
- 6) Valid Notarized Affidavit of Non-black listing by PWD/State/Central Departments/ PSU/ Autonomous bodies as per Form "J" (Page No.7) on Non-Judicial stamp paper of Rs.100/- duly signed by the authorized person of agency / firm. (Applicable only for Contractors / firms other than those registered with PWD Puducherry).
- 7) Declaration about Site Inspection & for Other Machineries & Tools and Plants to be deployed in the site.

Note:

- 1) All the above documents uploaded must be clearly displayed and seen by the tender opening authority.
- 2) **After Technical bid opened**
 - a) Contractors/firms other than those registered with PWD, Puducherry has to submit Original documents for the eligibility criteria Bid as stated in 'Form C'.
- 3) **After Financial bid opened**
 - a) *The lowest contractor should furnish all the original documents as mentioned in page No.4, 5, 7, & 9 of NIT.*
- 4) **Document to be submitted after acceptance:**
 - i. The contractor whose bid is accepted have to furnish the following licenses or proof of applying for obtaining the licenses within the time limits as prescribed under clause1 of Schedule 'F'.
 1. Employees Provident Fund Organization (EPFO) and Employees State Insurance Corporation (ESIC) registration certificate are required to be furnished by the contractor for works costing Rs. 1.00 Crore and more. However, the Executive Engineer concerned will ensure that (i) EPFO registration certificate is collected from the contractor if 20 or more employees/labourers are employed and (ii) ESIC registration certificate is collected from the contractor if 10 or more employees/ labourers are employed, which shall be final and binding on the contractor and shall be complied with.
 2. Whenever ESIC and EPFO are not applicable Buildings and other Construction Workers (BOCW) Welfare Board registration certificate will not be insisted.

- ii. Willingness certificate from concerned competent electrical contractor if required.
- iii. The Lowest Tenderer should produce Valid Notarized Affidavit of 'No back to back execution of work as per Form "G" (Page No.8) on Non-Judicial stamp paper of Rs.100/- duly signed by the authorized person of agency/ firm.
- iv. The Lowest Tenderer should produce the R.C. book, ownership documents for proof for documentary evidence of Own / Lease Agreement for the Machinery, Tools and Plants after receipt of letter of acceptance. In case the L1 contractor fails to produce the above documents, the tender liable for rejection and the EMD will be forfeited.

The General Conditions of Contract 2023 for Construction Works (Form 7/8) are available on the website www.thirunallarutemple.org/tender and the same can be viewed online by the intending contractors.

On the scheduled Time & date of opening, the Executive Officer authorizes the opening on the notified time. Contractor can access the particulars, after opening of tender in the website. The department will not liable for any delay in submission of tender.

The time allowed for carrying out the work as mentioned in column (7) which including monsoon period from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
